From the Mayor's Desk: October 1, 2020 and this will be the last newsletter of the year. I am re-doing the newsletter today because we found out our 2020 Census count is being extended into October. Census workers are trying to make sure everyone is counted. I am asking you to be counted for your city. county, and state. 13.5% of estimated 4,750 citizens equals 641 Brookland citizens that have not been counted in 2020 Census. This would mean a loss in revenue of \$13,198.19 a month, \$158,378.28 a year. 2030 will be the next Census count, and in that ten-vear period Brookland would lose \$1,583,782.80. This loss would not just be detrimental to the city of Brookland but would also affect the Brookland Fire Protection District. Brookland Street Department, Brookland School, and the list goes on. So, I ask you to be counted for your city, county, and state. The revenue generated by just being counted can mean the difference of having parks for citizens to enjoy, an animal park, curb and guttering on city streets and better drainage, which equals a strong self-sustaining City of Brookland for the future. The American Made Store is open at the corner of Crain Rd and Hwv 49. If you have not had a chance to visit. I want to encourage you to

drop by. Try their home-made sandwiches for lunch and their ice cream is really good. White milk and chocolate milk are in glass containers and canned goods in jars, like jelly, jams, beets, etc. are like grandma made them. They also have a metal shop show room and build houses and shop buildings too. So, stop by and check them out.

First Community Bank is under construction at the corner of West School Street and Hwy 49. Hopefully, the weather will cooperate, and we will have a First Community Brookland Branch open by spring.

There is a lot of residential construction going on in our city. Brookland Hills residential subdivision's final Phase 4 is started, Gatlin Crossing at Whispering Hills infrastructure is underway, and Hidden Creek Subdivision Phase I has been approved.

By the time you receive this letter hopefully, School Street be overlaid. This asphalt overlay was made possible through the state aid street program.

COVID-19 has thrown us a big curve this year. Our positive numbers continue to grow in Craighead County. The mask issue has really caused strong issues for all. Those for and those against. When Governor Hutchinson wanted all cities to pass an ordinance mandating masks, I was against this. I felt if a

mask was required it should be a state mandate. I could not see a city requiring citizens to wear a mask and citizens in the county or neighboring city not required. People would avoid your city or how would vou enforce Now the mandate. that Governor Hutchinson has made it a mandate, I will follow the law. I hate wearing the masks, as do most. I just do not want to take a chance of getting COVID-19 much less pass it on to my elderly loved ones, other family members, neighbors, employees here at city hall. We are here working every day, but our lobby will remain closed. Business will continue to be conducted by phone or at our drive through. We are holding our city council planning meetinas and commission meetings here at hall. Plexi-glass protectors have been installed for council members at their meeting desk, and around 17 citizens will be permitted in the meeting area. Citizens that attend will be asked a couple of questions, have their temperature taken, and wear a mask to attend the meeting. Seating is around 6 feet apart.

Well holiday season is almost upon us. Will there be Halloween? Will we have our annual holiday events. Right now, we do not know the answer. I have spoken with other cities and they have already canceled their

seasonal events. We are asking that you check our web site cityofbrookland.com for upcoming announcements. On November 6th we will post our decisions.

I pray all of you have a happy holiday season, and a Blessed safe 2021.

Brookland Utilities Online Bill Pay

Brookland Utilities (BU) has partnered with Nexbillpay to give residents the option to pay their bill by phone or online. There is a \$2 or 2.75% fee associated with online pay.

However, due to problems with receiving utility bills from post office in a timely manner, BU is encouraging residents to set up their accounts with Nexbillpay, so they can receive notification of the amount of the new bill each month by free text and/or email (standard message and data rates may apply). To sign up, each resident must have their account number. The online pay can be access

through our website cityofbrookland.com.

Hopefully this will eliminate the water bill delivery issue. Customers do not have to actually pay their bills online, but having an account established allows them to receive electronic notification of the amount they owe. The phone number to call in your payment is 1-844-293-9814. We have also recently added a new feature regarding text and/or e-mail alerts a few days prior to disconnects. If you have recently changed your phone number, please contact our office to ensure that we have the correct number on file to send the notifications to.
