# Brookland City Council Minutes August 10, 2020

The meeting was called to order at 7:00 PM by Mayor Jones.

Roll Call: Council present: Jason Cooper, Martin Crain, Wilson Shipman, Mike Bishop, Lacey Elder, David Gambill, Mayor Kenneth Jones, Attorney Kevin Orr, and City Clerk Billy Dacus.

#### **Old Business**

## Ordinance 2020-07 - Rezone property at 34 Crain Rd from A-1 to C-2 - First Reading:

Mike Bishop made a motion to suspend the rules and read the second reading of Ordinance 2020-07 by title only. Lacey Elder seconded the motion. Mayor Jones stated motion and second, then opened the motion to suspend the rules to council for discussion. Being none, Mayor Jones called for a vote. Mayor Jones announced the motion to suspend the rules and read the second reading of Ordinance 2020-07 by title only passed 6 Yays to 0 Nays.

Kevin Orr read Ordinance 2020-07 by title only. This is the second reading of this ordinance (8/10/2020). The first reading of the ordinance was done in the August meeting (7/13/2020).

#### **Discuss Gatlin Crossing:**

The request was started in April but has been slow due to the virus and other issues in the county office. The Mayor said there would be a public hearing in the County Judge's office on August 26.
