#### 3. Brookland Parks Committee Update:

David Loggins, Parks Committee Chairman was present to give the council an update. Loggins explained that the city has received a bid from Happy Playgrounds, for playground equipment for the two small city parks, in the amount of \$244,385.11, about half the amount of another bid received. Loggins added that the road has been added to the sportsplex.

## 4. Brookland Art Classes are interested in painting a mural on buildings downtown:

No one was present to speak on this issue. Mayor Jones asked the council to consider this request and possible ideas of what could be painted. Jones added that he would ask the art classes to attend a future meeting to discuss this further.

## 5. Zach Dunivan – 708 N. Holman – food trucks – no zoning to support:

Zach Dunivan, of 123 Harper Drive in Brookland, came before the council to ask about possible zoning for the use of food trucks at 708 N. Holman Street. This property is currently zoned for mobile homes, however, Dunivan is interested in creating a food truck court at this location. Dunivan asked if that property could be rezoned for this purpose. Mayor Jones explained that the council had previously considered zoning a space for food trucks in the city, however, he was not sure that particular property could be zoned for such use. Jones explained that the city attorney, Kevin Orr, could research this possibility and give an update at the next council meeting. Jones asked Dunavin to attend next month's meeting (Tuesday, January 9) and more information would be provided. Attorney Kevin Orr asked Dunavin if he owned the property. Dunavin explained he currently has the property under contract and closing is pending on whether or not it can be zoned for food truck space.

## 6. Resolution 2023-21 – Adopting 2024 Budgets:

Mayor Jones asked the council to make an adjustment to pg. 2 of the proposed 2024 General Fund budget. The change is reflective of the city purchasing new police vehicles and needing to equip them with (6) 2-way police radios. The council had no comments or questions regarding that change or any of the other proposed budgets.
