New Business:

1. Review Meeting Procedures:

Mayor Jones presented a copy of Ordinance No. 2016-02, *An Ordinance Establishing City Council Meeting Rules and Procedures* to councilmembers. There was no discussion or questions from the council on this item. The city council will continue to conduct its meetings according to this ordinance.

2. Brookland Parks Committee Update:

David Loggins, Parks Committee President, mentioned that an ad for the Sportsplex recently ran in the Arkansas Democrat Gazette. Interested parties have until February 7 to submit bids. They will then be read by Mayor Jones and Fisher & Arnold. Small parks will be bid out soon. Those bids may run in the Jonesboro Sun for local contractors. Next Parks Committee meeting scheduled for Monday, January 16, 2023. Mayor Jones asked the committee if there were any questions.

3. Resolution 2023-01: Amending the 2022 General, Street, and Utility Fund Budgets:

A resolution to amend the General, Street, and Utility Fund Budgets beginning January 1, 2022, and ending December 31, 2022, is needed. The budget was adopted December 13, 2021. The city needs to adjust the budget and close it. The city must approve the adjustment of the budget for the year

2022. The final budget shall be as follows: General Fund: \$1,723,617.09, Street Fund: \$1,046,339.00, and Utility Fund: \$1,407,218.00.

Miscellaneous:

1. Ordinance Codification Books:

Mayor Jones asked councilmembers to return their old codification books to be updated as well as give new books to new councilmembers.

2. National Day of Racial Healing 2023 Proclamation:

Mayor Jones read the National Day of Racial Healing 2023 Proclamation. January 17, 2023, is hereby proclaimed as the National Day of Racial Healing 2023 in the City of Brookland, Arkansas.

3. Sale of Land on Barnett Street:

Mayor Jones explained that the Barker Brothers want to purchase an acre of land (outlined on the map handout) and are possibly interested in purchasing the entire piece of land, down to the existing creek, for a price of \$40,000. The land will be used for their asphalt business. They plan to build 2 steel buildings for use in running their business.

4. State Aid Street Money:

Mayor Jones read aloud estimates for proposed improvements to a building on Missouri Street. He also discussed possible future plans for putting a roof over the old lagoon. Mayor Jones expressed that these items could be discussed at a later date due to the high costs of construction right now.
