9. West Matthews Street – extension to Hwy 49N:

Mayor Jones presented a map to the council showing the proposed extension of West Matthews onto HWY 49N. Jones explained this land is being donated to the City of Brookland by Buddy Couch for increased ease of traffic flow within the city. This road will provide a right-hand only turn option onto HWY 49N and will allow for traffic to exit from HWY 49N (both north and southbound lanes) onto W. Matthews Street. Jones expressed to the council that this addition would help with drainage in the area as well.

Mayor Jones asked the council to consider the appointment of Pamela McGee to sign checks on behalf of the city of Brookland. Jones stressed that there needs to be 3 check signers among the councilmembers, including the city clerk/treasurer. Mike Bishop was previously a check signer and recently resigned his position on the council due to his employment by the City of Brookland as City Engineer. This left an open position for check signer.

Jones discussed feedback and discussions he had with other cities regarding the pros and cons of speedbumps. One major complaint Jones presented involved the increased response time of emergency vehicles in areas where speed bumps are utilized. Jones urged the council to discuss other options to aid in reducing speeding vehicles through the city. Other options discussed among the councilmembers included letters to citizens, increasing fines for speeding, flashing digital speed signs, and the placement of stop signs in specified areas. These would include 3-way and 4-way stop areas.
