*Mayor Jones explained to the council why the General Fund has decreased. The City of Brookland was awarded a mitigation grant to clean out the Maple Slough ditch. The grant is a refundable grant in the amount of \$300,000.00, with a 25% match. To date, the City of Brookland has not been reimbursed any funds that have been paid for work completed. The City has spent around \$160,000.

Mayor's Notes:

Discuss Park Hours open at sunrise, close at sunset:

Mayor Jones advised the council that the proposed park hours for the city parks will include opening at sunrise and closing at sunset. The council had no opposition to this.

• City of Brookland Police Chief, Jon Moore (PD open positions and salaries):

Jon Moore, City of Brookland Police Chief, was present to speak to the council about the current police department shortage of 2 full-time officers. Moore explained that one of the full-time officers went back to work for the department that BPD had just hired them from because of a better salary package. Moore went on to say that the BPD had been asked to look at hiring a 3rd SRO by Brookland Public Schools. Moore urged the council to consider amending the existing salary package in order to recruit and retain qualified officers with a competitive benefits package. Moore explained that the Arkansas State Police, Arkansas State University Police Department, Craighead County Sheriff's Department, and two other larger cities have increased the salary package for their police officers. The council asked Moore to present the current salary range as well as a proposal for salary and benefits package that could be more lucrative to current and prospective police officers.

Mayor Jones asked for a motion to adjourn the meeting.
