New Business:

1. MARCK Recycling - taking over residential trash pickup after council review of contract:

Steven Pauli and Deena Johnson, with MARCK Recycling and Waste came before the council to field questions about the contract for services they submitted to the city for review. Council member Wilson Shipman asked about the cost per household for trash pickup. The MARCK contract includes a price per household of \$17.95 per month. Council member Pamela McGee asked Mayor Jones if there could be additional fees that would need to be added by the City of Brookland for bill collection. Mayor Jones stated that the city currently receives 5% from Dedman's Sanitation Services for distributing and handling carts and for bill collection. Jones added that something between a \$1 - \$3 surcharge would need to be added to the MARCK fees for bill collection services. The current price per household for Dedman's Sanitation Services is \$14 for senior citizens and \$16 for all others. Jones asked Pauli about a discounted rate of \$2 per household for senior citizens. Pauli confirmed that was correct. Shipman stated that he would like to remain with Dedman's Sanitation. Jones included that the main concern with Dedman's was their handling of leach agent, which has been addressed. The council concluded that they would like to keep in contact with MARCK for future possibilities, however, at this time, the City of Brookland will remain with Dedman's Sanitation.
