ORDINANCE NO. 2008-16

AN ORDINANCE ACCEPTING CERTAIN LANDS ANNEXED TO THE CITY OF BROOKLAND, ARKANSAS, BY ORDER OF THE COUNTY COURT OF CRAIGHEAD COUNTY, ARKANSAS, BEING SEVEN TRACTS OF LAND ADJOINING VARIOUS PARTS OF THE PRESENT CITY LIMITS; ASSIGNING SAID ANNEXED TERRITORIES TO WARDS ONE AND THREE.; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES

WHEREAS, a petition for the annexation of seven particular tracts of land to the City of Brookland, Arkansas, hereinafter described, was duly filed in the County Court of Craighead County, Arkansas, on August 19, 2008; and

WHEREAS, said petition for the annexation of these lands was duly signed by a majority of the owners of real estate in each of said tracts to be annexed; and

WHEREAS, an order setting a hearing upon said petition were entered, notice duly published of said hearing, and a hearing upon said petition was duly had and held on September 22, 2008, at which hearing it was duly found and declared that said petition for annexation was right and proper and that such lands hereinafter described should be annexed to the City of Brookland, Arkansas; whereupon an order of annexation was made and entered; and

WHEREAS, thirty (30) days having expired since the order of annexation dated September 22, 2008, and no proceedings to prevent said annexation having been filed in the Circuit Court of Craighead County, Arkansas, said annexation proceedings were in all things confirmed by the County Court of Craighead County, Arkansas, by its order dated

SEPTEMBER 22 ,2008;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE CITY COUNCIL OF THE CITY OF BROOKLAND, ARKANSAS:

Section 1. All of the territory and lands annexed to the City of Brookland, Arkansas, by order of the County Court of Craighead County, Arkansas, dated September 22, 2008, be, and they are hereby accepted by the City of Brookland, Arkansas, and said territories hereinafter described shall be hereafter deemed and taken to be a part and parcel of the limits of the City of Brookland, Arkansas, and the inhabitants residing therein shall have and enjoy all of the rights and privileges of the inhabitants within the original limits of the City of Brookland, Arkansas.

Section 2. The portions of land and territories hereby annexed to and accepted by the City of Brookland, Arkansas, are more particularly described as follows:

Tract 1:

That part of the North Half of the Northeast Quarter, that part of the Southeast Quarter of the Northeast Quarter, and that part of the Northeast Quarter of the Southeast Quarter, all in Section 20, Township 20 North, Range 5 East, described as follows: Beginning at the Southwest corner of said NE1/4 SE1/4, said point being on the existing City Limits of Brookland, Arkansas, run thence East 218 feet to the West right-of-way of the railroad, run thence Northeasterly along said right-ofway 1465 feet, more or less, to the South line of Lot 165 of University Heights Addition, run thence Northwesterly along the South line of said Lot 165 a distance of 210 feet, run thence Northeastelry parallel with the railroad a distance of 440 feet, more or less, run thence Northerly 565 feet, more or less, to the South line of Lot 37-A of University Heights Addition, run thence Westerly 242.5 feet to the Southwest corner of Lot 37-B of University Heights Addition, run thence Northwesterly along the West line of Block One a distance of 1525 feet, more or less, to the South line of Lot 21, run thence Westerly along said Block One a distance of 1720 feet, more or less, to the Southwest corner of Lot 4 of University Heights Addition, run thence Northerly 190 feet to the North line of said N1/2 NE1/4, run thence West along said North line 365 feet, more or less, to the Northwest corner of said N1/2 NE1/4, run thence South along the West line of said N1/2 NE1/4 a distance of 1145 feet, more or less, run thence East along the North line of Block 2 of University Heights Addition a distance of 1495 feet, more or less, run thence Southerly 295 feet, run thence Westerly 175 feet, run thence Southerly 300 feet, run thence East 175 feet, run thence South 100 feet, run thence West 175 feet, run thence South 2120 feet, more or less, to the true point of beginning, said lands being University Heights Golf Course and the platted lots owned by Adam Smith, containing 100 acres, more or less.

Section 3. The land and territories annexed to the City of Brookland, Arkansas, and herby accepted by the City of Brookland, Arkansas, are assigned and attached to Wards

TRACTS 1-2-3, WARD 3 ; TRACTS 4-5-6-7, WARD 1

Section 4. It is herby found and declared by the City Council of the City of Brookland, Arkansas, that there is an extreme urgency that the territory herein be immediately annexed to and accepted by the City of Brookland, Arkansas, so that said property and the citizens and property owner of said territories described herein can be entitled to fire, police, zoning and other protection and benefits, and that said benefits are urgently needed now in order to allow orderly growth and development of said lands and territory, therefore, an emergency is declared to exist, and this ordinance being necessary for the preservation of the public peace, health and safety, it shall take effect and be in full force from and after its passage.
