ORDINANCE NO. 2012-09

AN ORDINANCE VACATING AND ABANDONING AN ALLEYWAY BETWEEN LOT 7 OF BLOCK F OF THE RYANS SURVEY AND LOT 1 OF THE HAYES ADDITION TO THE TOWN OF BROOKLAND, ARKANSAS; AND DECLARING AN EMERGENCY.

WHEREAS, a request for abandonment of the alleyway between Lot 7 of Block F of the Ryans Survey and Lot 1 of the Hayes Addition of the Town of Brookland, Arkansas, located in Section 29, Township 15 North, Range 5 East, Craighead County, Arkansas, has been made to the City Council of the City of Brookland, Arkansas; and

WHEREAS, the City Council has obtained the written consent by all landowners adjoining this alleyway and has ascertained that the alleyway or the portion thereof, hereinbefore described, has heretofore been dedicated to the public use as an alleyway herein described; has not been actually used by the public generally for a period of a least five (5) years subsequent to the filing of the plat; that all the owners of the property abutting upon the portion of the alleyway to be vacated have filed with the council their written consent to the abandonment; and that the public interest and welfare will not be adversely affected by the abandonment of the alleyway.

NOW, THEREFORE, be it ordained by the City Council of the City of Brookland, Arkansas:

- Section 1. The City of Brookland, Arkansas, releases, vacates, and abandons all its rights, together with the rights of the public generally, in and to the alleyway designated as follows: Alleyway between Lot 7 of Block F of the Ryans Survey and Lot 1 of the Hayes Addition to the Town of Brookland, Arkansas.
- Section 2. A copy of the ordinance duly certified by the city clerk shall be filed in the office of the recorder of the county and recorded in the deed records of the county.

Section 3. Emergency Clause

It is hereby found and determined that it is necessary for a timely sale that the alleyway be abandoned; therefore, an emergency is declared to exist so that this ordinance shall be in full force and effect from and after its passage.
